WHAT IS REFRESH SMOKE ODOR ELIMINATOR?

Refresh is chemically designed to eliminate chemically based odors at their source. Smoke molecules and other strong odors get trapped deep into fabrics and other textiles. Other products attempt to cover up these odors allowing the odors to resurface. Refresh Odor Eliminator is chemically designed to penetrate the surface and attack the source of the odor to eliminate it for good. Safely treats cabinets, refrigerators, curtains and everywhere paints can't go.

WHAT IS FUTURE-GUARD TECHNOLOGY?

When the odor source is completely eliminated, some of the safe bacteria hibernate until new organic-based odor causing substances are introduced. This restarts the cycle of odor removal and eliminates the source again.

DIRECTIONS

1. Use Refresh sparingly. A little goes a very long way.

2. Refresh Smoke Odor Eliminator is safe to use on any water safe fabrics or surface. Be sure to test an inconspicuous area before application.

3. Lightly mist carpeting, draperies and any other fabric or odor absorbing surfaces using a very fine mist from a trigger sprayer, atomizer or pump-up sprayer. Do not overspray as a sticky film could be left on smooth surfaces like countertops and furniture.

4. Saturate furnace filter(s) to distribute the product into the HVAC system and duct work.

5. With fan on, spray a fine mist into each intake vent and run the fan with the windows and doors closed for at least two hours to allow the product to thoroughly be recirculated and distributed.

The initial scent of Refresh will dissipate over time leaving a pleasant residual fragrance that will ultimately disappear completely. Enclosed spaces or areas without good ventilation may take longer.

VEHICLE TREATMENT: Spray a light mist of product 4-5 times (total) in the front and back of the interior of the vehicle (on seats, carpets or headliners). Allow 10-15 minutes for the product to work. Apply more for problem odors. The cover scent will dissipate slowly as the enzymes eliminate the source of the odor. Ultimately, no odor or scent will exist.

SEVERE VEHICLE SMOKE ODOR PROBLEMS: Spray the headliner and seats 4-5 times each. Saturate the in-cabin air filter. While the vehicle is running and the air conditioner is set in the recirculate air mode, spray 4-5 times on the floor mats so the product can flow through the ventilation system. Keep the windows rolled up for 15 minutes. Roll the windows down to let the scent dissipate.

Refresh Smoke Odor Eliminator contains live bacteria that cannot be exposed to extreme temperatures. Make sure that unused product is stored above freezing and below 110 F for optimal performance. For high or low temperature treatments, insure treatment area is within this temperature range during and after treatment which will allow the bacteria to digest the source of the odor problems.

RECOMMENDED TOOLS

For best results, use a traditional pump sprayer that can be set to ultra fine mist. If using an existing sprayer, ensure it is clean and contaminate free.

Pro-Tip:

- After treatment, high-gloss surfaces may need to be wiped down with a warm moist rag.
- Residue from pesticides, herbicides and other cleaning agents could interact with the bacteria and enzymes in OdorGhost and decrease or negate the effectiveness of the product.

CLEANING INSTRUCTIONS

OdorGhost dries clear so no cleanup is required. If a pump sprayer was used for application, the sprayer can be rinsed with clear water. After application the sprayer should be rinsed with warm water.

STORAGE

This product should be stored at temperatures between 50-90° F (15-32° C). Protect product from freezing.

FIRE RATING

Meets NFPA Class A and UBC Class 1 as determined by ASTM E-84 and also passes the pill test.
